Scenario 1 Faulty electrical equipment caused a fire at a retail store, resulting in damage to the premises and goods.	 Documentation required when submitting the claim: Photographs of the damage Quotation for repair works
Scenario 2 A cook at a restaurant tripped while preparing food orders, resulting in a serious leg injury. The cook was medically unfit to work for a month, and needed medical and rehabilitation treatments as well.	 Documentation required when submitting the claim: Payslips for past 12 months from the accident Incident report Medical bills, reports and certificates
Scenario 3 A company vehicle from a transportation firm met with a traffic accident while delivering goods to a customer's factory, resulting in extensive damage to the goods.	 Documentation required when submitting the claim: Delivery order Traffic Police accident report Commercial invoice for the goods
