

Year End Giveaway - Terms and Conditions

1. Eligibility

- 1.1. The Year End Giveaway (the "Promotion and Lucky Draw") is organised by AIG Asia Pacific Insurance Pte. Ltd. ("AIG"). It will be held from 9 November 2022 to 15 January 2023, both dates inclusive (the "Promotion Period").
- 1.2. The Promotion and Lucky Draw will be administered and run by AIG and is only open to Singapore residents ("Eligible Individuals").
- 1.3. This Promotion is not valid in conjunction with any other promotions, discounts or offers offered by AIG.
- 1.4. Employees of AIG, and their immediate family members are not eligible to participate in the Promotion and Lucky Draw.
- 1.5. Eligible Individuals who successfully purchase a valid eligible policy, listed in clause 1.9 below, during the Promotion Period (each an "Eligible Policy" and collectively "Eligible Policies"), will be entitled to a corresponding number of chances to win a prize ("Prize") in the weekly draw that corresponds to the purchase date of the Eligible Policy ("Lucky Draw Chance"). Details of the weekly draws are at clause 2.2 below. Three (3) Eligible Individuals will be randomly selected to each win a Prize in each of the weekly draws (each a "Winner" and collectively "Winners").
- 1.6. Lucky Draw Chances are cumulative for each of the weekly draws. See Illustration a) in clause 2.4 below.
- 1.7. Eligible Individuals who purchase selected Eligible Policies may also receive a gift and additional gift, details of which are contained in clause 1.9 below (referred to as "Gift" and "Additional Gift" respectively).
- 1.8. Eligible Individuals will only be entitled to the Lucky Draw Chances, Gift and Additional Gift provided that the specific requirements set out in 1.9 for the relevant Eligible Policy is met.
- 1.9. Details of the Eligible Policies and the Lucky Draw Chance(s) and Gift(s) (where applicable) for each are as follows:

Travel

- 1.9.1. Subject to clause 1.9.2, Eligible Individuals who successfully purchase a Travel Guard® Direct policy (each an "Eligible Travel Policy") during the Promotion Period will be entitled to the corresponding number of Lucky Draw Chances per policy purchased, stated in Table 1 below. In addition, Eligible Individuals who purchase a Travel Guard Direct Single Trip Plan with a minimum premium of \$\$100 during the Promotion Period, will also be entitled to the Gift stated in Table 1 below. Please see Table 1 for details.
- 1.9.2.The Eligible Individual will only be entitled to the Lucky Draw Chances(s), and the Gift where applicable, provided:
 - a) the Eligible Travel Policy is not subsequently cancelled; and
 - b) the purchase is made via www.aig.sg/personal/travel-guard.

In addition, to be entitled to the Gift where applicable, the Eligible Individual must also have entered the promo code "AIGTGD" in to the "I have a promo code" field in the user journey.

For the purchase of a Travel Guard Direct Family policy, only the main policyholder will be eligible to receive the Lucky Draw Chances and the Gift where applicable.

Auto

- 1.9.3. Eligible Individuals who successfully purchase AIG Car Insurance Collision Only or AIG Car Insurance Complete (each an "Eligible Auto Policy") during the Promotion Period, will be entitled to 10 Lucky Draw Chances per policy purchased, and the Gift stated in Table 2 below provided:
 - a) The Eligible Auto Policy is not subsequently cancelled; and
 - b) the purchase is made via www.aig.sg/personal/car-insurance.
- 1.9.4. Eligible Individuals who comply with 1.9.3 above will also be entitled to the Additional Gift stated in Table 2 below provided:
 - the Eligible Individuals download the AIG On the Go mobile application from Apple or GooglePlay app stores or from www.aig.sg/otg;
 - b) the Eligible Individuals register for a new AIG On the Go account using the same vehicle registration number and email address which was provided to AIG at the point of purchase of the Eligible Auto Policy during the Promotion Period. For the avoidance of doubt, the Eligible Individual will only be entitled to the Additional Gift if the vehicle registration number and email address used to register the new AIG On the Go account, had not previously been used to register for an AIG On the Go account; and
 - c) At the time the Additional Gift is emailed to the Eligible Individual (i) the AIG On the Go mobile application must not have been deleted; and (ii) the AIG On the Go account must not have been deleted.

Personal Property

- 1.9.5. Subject to clause 1.9.6, Eligible Individuals who successfully purchase an eligible Personal Property policy stated in Table 3 below (each an "Eligible Personal Property Policy") will be entitled to the corresponding number of Lucky Draw Chances per policy purchased, as stated in the same Table. In addition, Eligible Individuals who purchase an Enhanced Public Housing Contents Insurance (5-year Plan), Homes Advantage Package Plan, and/or Homes Complete (3-year Plan) during the Promotion Period, will also be entitled to a one-time general air-conditioner servicing for up to two (2) air-conditioner units located at the same premises. Please see Table 3 for details.
- 1.9.6. The Eligible Individual will only be entitled to the Lucky Draw chances(s), and the Gift where applicable provided:
 - a) the Eligible Personal Property Policy is not subsequently cancelled;
 - b) the purchase is made via www.aig.sg/personal/home-insurance or by completing the application form in the direct mailer with the manual code number W3221111 and W3221201, and returning to AIG before the end of the Promotion Period. For the avoidance of doubt, the completed application form must be received by AIG before the end of the Promotion Period for the Eligible Individual to be entitled to the Gift; and
 - c) the Eligible Personal Property Policy is purchased without any entry in the 'Producer Code' field on the online purchase path via the link in 1.9.6 b) above.

Accident and Health

- 1.9.7. Eligible Individuals who successfully purchase Sapphire Enhanced Choices, Domestic Helper Insurance and/or Advanced Silver ("Eligible Accident and Health Policy") during the Promotion Period, will be entitled to 3 Lucky Draw Chances and S\$50 worth of Dairy Farm Vouchers provided:
 - a) the Eligible Accident and Health Policy is not subsequently cancelled
 - b) the purchase is made via www.aig.sg/personal/accident-and-health; and
 - c) the Eligible Accident and Health Policy is purchased without any entry in the 'Producer Code' field on the online purchase path via the link in 1.9.7 b) above.

For the purchases of Sapphire Enhanced Choices Individual policy and Sapphire Enhanced Choices Spouse policy, only the main policyholder will be eligible to receive the Lucky Draw Chances and the Gift.

- 2.2. The First Draw and the Second Draw will both be conducted at the premises of AIG office at 78 Shenton Way, #09-16 AIG Building, Singapore 079120.
- 2.3. Each Eligible Individual shall only be eligible to win one Prize. Upon being selected to win a Prize, the Eligible Individual will not be eligible for all subsequent draws, even if further Eligible Policies are purchased which would have ordinarily entitled the participant to participate in subsequent draws.

- c) Customer C purchases AIG Car Insurance Complete on 30 November 2022 which entitles Customer C to 10 Lucky Draw Chances for the 4th weekly draw. - 3.1. - 3.2. AIG shall not be liable if the delivery of any Redemption Notification to the relevant Winner is unsuccessful.

AIG will send the Gift, and the Additional Gift (where applicable), within six to eight weeks after the end of the Promotion Period, via email or SMS, to the email address or mobile phone number of the Eligible Individual which was provided to AIG at the point of purchase of the Eligible Policy.
- 4.2. The Gift and the Additional Gift are subject to the terms and conditions of the issuer, and AIG will not accept any liability in relation thereto.
- 4.3. AIG shall not be liable if the delivery of the Gift, and the Additional Gift (where applicable), to the relevant Eligible Individual is unsuccessful. AIG reserves the right to deal with any Gift and/or Additional Gift returned to it for any reason in any manner it deems fit.



- 4.4. Once the Gift is emailed, Eligible Individuals to whom the Gifts have been emailed to will not be allowed to cancel their policies.
- 4.5. The Gift and/or the Additional Gift is not transferable or exchangeable for cash, credit or kind. AIG reserves the right to replace the Gift and/or the Additional Gift with other items of similar value without prior notice.

5. General Conditions
